Further to the inside information communication made on 16 January 2025 (registered under number 2552) announcing the invitation by CaixaBank, S.A. (the "**Issuer**") to holders (the "**Holders**") of its outstanding EUR 1,250,000,000 Perpetual Non-Cumulative Contingent Convertible Additional Tier 1 Preferred Securities (ISIN: ES0840609012; the "**Preferred Securities**"), to tender such Preferred Securities for purchase by the Issuer for cash (the "**Offer**") up to a maximum aggregate principal amount expected to be equal to the aggregate principal amount of the New Preferred Securities (the "**Maximum Acceptance Amount**"), the Issuer announces that, following today's successful pricing of the New Preferred Securities for an aggregate principal amount of EUR 1,000,000,000, the Maximum Acceptance Amount in relation to the Offer is EUR 1,000,000 (equal to the aggregate principal amount of the New Preferred Securities). The Issuer reserves the right to increase or decrease the Maximum Acceptance Amount, in its sole and absolute discretion, except as required by applicable law and regulations. In any event, the Issuer will announce the aggregate principal amount of the Preferred Securities tendered which the Issuer expects to accept for purchase pursuant to the Offer upon receipt of the relevant Iberclear Instructions prior to the Market Deadline in the announcement of the results of the Offer. Such aggregate principal amount may be lower than the Maximum Acceptance Amount.

The Offer is being made on the terms and subject to the conditions contained in the tender offer memorandum dated 16 January 2025 (the "**Tender Offer Memorandum**") and is subject to the Offer restrictions set out below and more fully described in the Tender Offer Memorandum. Copies of the Tender Offer Memorandum are (subject to the Offer restrictions) available from the Tender Agent, whose contact details are set out below (see "*Offer and Distribution Restrictions*"). Capitalised terms used and not otherwise defined in this announcement have the meanings given in the Tender Offer Memorandum.

Each intermediary must comply with the applicable laws and regulations concerning information duties vis-à-vis its clients in connection with the Preferred Securities or the Offer and the Tender Offer Memorandum.


## Spain
