

MiFID II product governance / Professional investors and ECPs only target market – Solely for the purposes of the manufacturer's product approval process, the target market assessment in respect of the Notes has led to the conclusion that: (i) the target market for the Notes is eligible counterparties and professional clients only, each as defined in Directive 2014/65/EU, as amended (**MiFID II**); and (ii) all channels for distribution of the Notes to eligible counterparties and professional clients are appropriate. Each of Moody's Investors Service España, S.A., S&P Global Ratings Europe Limited, Fitch Ratings Ireland Limited and DBRS Ratings GmbH is established in the European Union and is registered under Regulation (EC) No. 1060/2009 (as amended). As such each of Moody's Investors Service España, S.A., S&P Global Ratings Europe Limited, Fitch Ratings Ireland Limited and DBRS Ratings GmbH is included in the list of credit rating agencies published by the European Securities and Markets Authority on its website in accordance with such Regulation.

According to Moody's Investors Service España, S.A., a rating of "A3" indicates an obligation judged to be upper-medium grade and are subject to low credit risk. The numerical modifier "3" indicates that the obligation ranks in the lower end of the generic "A" rating category.

According to S&P Global Ratings Europe Limited, a rating of “A” indicates that the obligation is somewhat more susceptible to the adverse effects of changes in circumstances and economic conditions than obligations in higher-rated categories. However, the obligor's capacity to meet its financial commitments on the obligation is still strong. The modifier “-” indicates that the obligation ranks in the lower end of the generic “A” rating category.

According to Fitch Ratings Ireland Limited, a rating in the “A” category indicates that expectations of default risk are low as the capacity for payment of financial commitments is considered strong. This capacity may, nevertheless, be more vulnerable to adverse business or economic conditions than is the case for higher ratings. The modifier “-” indicates a ranking in the lower end of the “A” rating category.

According to DBRS Ratings GmbH, a rating of “A” category indicates that the capacity of payment of financial obligations is substantial, although it may be vulnerable to future events, but qualifying negative factors are considered manageable.
